

A professor required us to have this book during class, and we all gave a collective groan when we saw the length. It's big, and we figured that meant a lot of reading. We were wrong. The book is in very large print, and has a lot of cartoons and illustrations. It reminds me a lot of language books for elementary schools. To use this in a graduate level class was almost a bit insulting. We got through it fast, some reading the entire book during the weekend. No one had any issues with it. There were no page numbers as someone stated, but we were assigned chapters and not pages. The content itself was decent, but nothing that blew me away. It helped with how to set up a mediation which is what's required from the course I took. It guided you through the steps well. But the entire book was how to do the mediation, and not really why it's important, how to deal with difficulties, etc. It was useful, but by no means would I willingly have purchased it.

The Mediator's Handbook is very useful. However, why is some of the information in the book more useful and workable than other parts? The definition of mediation is simply: intervention in a dispute in order to resolve it. In other words, resolution of conflict. I recommend this book, at least those parts of it that are based upon the laws of war of Sun Tzu found in Sun Tzu: The Technology of War. I refer to those chapters on "Understanding the Conflict" and "Solving the problem." The authors themselves may or may not know why parts of the book are more consistently efficacious of result than others. I doubt they can actually cite the laws of war which make some of the book quite productive of a result. This is not to fault them in the least. So, if you wish to use this book use it in conjunction with the translation of Sun Tzu referenced earlier. I have found the two together work together well and will assist greatly in understanding why something works and why some things do not.
